Building Energy Reporting and Benchmarking

September 11th, 5:30 PM to 8:30 PM Embassy Suites Hotel 550 Winter Street, Waltham, MA

The City of Boston has joined the ranks of New York City, Philadelphia, Washington, D.C., Seattle, San Francisco, and other major U.S. cities that have enacted energy reporting and disclosure requirements in their jurisdictions. By passing the Building Energy Reporting and Disclosure Ordinance, Boston has highlighted that energy efficiency in existing buildings is the single most important component of the City's plan to reduce greenhouse gas emissions 25 percent by 2020.

Brian Swett, Chief of Environment and Energy for the City of Boston, will explain the Ordinance and will provide examples of how this may present business opportunities for AEE members. Topics will include:

- The primary purpose of the ordinance and how it is being implemented
- Which buildings or building types will be required to undergo energy evaluations?
- Will building owners be required to achieve certain efficiency levels?
- Are there fines or penalties for non-compliance?
- What engineering skills and/or tools are required to report the data?
- How to work with local utilities to obtain the necessary data

The Building Energy Reporting and Disclosure Ordinance is part of the City of Boston's Climate Action Plan. This Ordinance requires all large and medium sized buildings to report their annual energy and water use. The Ordinance is intended to encourage building owners to participate in local utility energy efficiency programs and educate tenants on building
